I. CALL TO ORDER, PLEDGE OF ALLEGIANCE, ROLL CALL

Meeting called to order by Chairman Brad Hanson at 5:35 pm. The pledge of allegiance was recited and quorum was noted.

II. PUBLIC COMMENT

Laurel Marsters expressed concerns about paying water master fees for her 3rd priority water right on Baxter Creek. She has not received water in eight years and believes she should not pay a water master fee but does not want to relinquish her water right. The board gave direction to lan Sims to draft a correspondence detailing the concerns present to be sent to the WAC legal staff for review and recommendation. Mr. Sims will prepare a draft for review at the next WAC meeting.

Mike Trask would like to see the various streams and waterways in the Susan River Watershed become individual decrees. The board expressed the fact that they operate the system on the Susan River decree that was assumed by the district in 2008 when DWR turned over service.

Ramsey Wood made a motion to approve the agenda, Mike Bartley seconded and the motion passed. All.

B. Approval of 11/10/16 regular meeting minutes.

Daren Hagata made a motion to approve the 11/10/16 minutes, Ramsey Wood seconded and the motion passed. All.

IV. ITEMS FOR BOARD DISCUSSION AND/OR ACTION

A. Discussion and recommendation for approval to RCD of Susan River Water Master Service Area (SRWMSA) Annual Report for Fiscal Year 2015-2016 – Sims.

Mr. Sims presented the Susan River Water Master Service Area Annual Report for FY 2015/16. Mr. Sims stated that he spoke with the district's Water Master, Than King, to discuss measurement data for the 2016 irrigation season beyond what is provided by the California Data Exchange Center (CDEC). As a new water master, Than spent most of this past irrigation season learning the system and servicing the users. With the combination of the Water Master not having the manpower or capacity to successfully

attain measurement data during the irrigation season on top of being unacquainted with the system, additional measurement data was not attained for the 2016 irrigation system. Mr. Sims made a note that it is on the district's agenda to implement at least 4-6 measurement devices throughout the service area over the next two months. This will assist the water master immensely with data collection while sustaining water delivery and customer satisfaction.

Ramsey Wood made a motion to approve to the RCD of Susan River Water Master Service Area (SRWMSA) Annual Report for Fiscal Year 2015-2016, Mike Bartley seconded and the motion passed. All.

V. REPORTS

A. Watermaster Report - Sims.

Than King is on paternity leave and did not attend the meeting. Mr. Sims reported on the status of the water master's employment. Than has resigned as water master of the Honey Lake Valley RCD. Mr. Sims provided a water master job description to be advertised locally as well as outside of the region specially targeting irrigation districts and college campuses with agricultural programs (CSU Chico, Cal Poly, UNR, etc.). It is Mr. Sims' intent to have the water master job description finalized and published by December 15th.

B. RCD Report – Cabodi for Langston.

Larry Cabodi reported to the WAC board that he will not be running for re-appointment to the RCD board. He stated there will be a board vacancy but he will serve until his seat is filled. He recommended that a member of the WAC board apply to be an RCD board member.
